
WHY A NON-EXCLUSIVE FRANCHISE?





LEVEL PLAYING FIELD

- Notify Builders in writing
 - Builders must select hauler from approved list
- Pursuing reported alleged violations
 - Public
 - Franchisees
- Reviewing submittals
 - Gate tags may ID hauler
 - Staff verify hauler is or is not authorized

- Enhanced Field Leveling
 - Leverage contract compliance angle
 - Pursue enforcement options via Code Compliance
 - Deploy field staff to monitor
