



- **Introduction To Recycling Class:** Since the 90's, NCRA has taught ITR 37 times - most if not all at the Recology SF's Tunnel Road Environmental Learning Center, ITR offers both newcomers and seasoned professionals a critical overview of current Recycling and Zero Waste concepts, practices and terminology, with guest speakers, thought-provoking exercises and group discussions. Another sold-out class was held in February 2025. Day 1 started with a presentation on San Francisco's recycling and composting programs, followed by a visit to the Artist in Residence Studio and around the rest of the Transfer Station site. Day 2 was held via Zoom. The 2026 class will be held on January 26 and 27. Thank you, Recology SF!
- **Recycling Update:** Recycling Update 2025 was held in March at Scottish Rite Center in Oakland, CA. The program included presentations from 25 Zero Waste industry leaders from across Northern California and Nevada. With 542 registrants - the great majority in-person, were resource recovery professionals, job seekers and students from around Northern California, The 2025 Recycling Update was one of our most successful conferences to date receiving an 80% approval rate from survey respondents on the quality of speakers and presentation topics.

The 30th Recycling Update will be held on Tuesday, March 25, 2026 at San Francisco State University's McKenna Theater. We expect another high energy Zero Waste conference with a continued focus on the latest in extended producer responsibility, local and state legislation, recycling markets, highlighting innovative repair and reuse programs. - **Zero Waste Tour:** Sixteen NCRA members toured the SMaRT Station (Sunnyvale Materials Recovery and Transfer) and FabMo, an amazing creative reuse non-profit which works to keep textiles and designer goods out of the landfill.
- **Annual Meeting:** In July, SF Environment Department hosted the Annual Members Meeting at their new office. Fifty-eight members registered for the hybrid meeting to network and celebrate NCRA's yearly achievements. Members provided important feedback on member activities, Recycling Update, among other topics. It was one of the most engaging to date.
- **Legislative Partnerships and Advocacy in Sacramento:** In May, the Zero Waste Advocacy Committee organized "NCRA Visits the Capitol," marking our second legislative day in over a decade. More than 31 members from across Northern California met at the state Capitol to learn about NCRA's 2025 priority bills and lobbied the State Legislature. Committee leadership, Californians Against Waste, and the California Product Stewardship Council led discussions on the legislative process, and provided essential background on Waste and Toxic Reduction.

Over 28 meetings were conducted with State Legislators to ask for their vote on NCRA's priority bills and help answer any questions they had. Twenty-eight meetings were held with legislators and/or staff including Senators Scott Weiner and Tim Grayson, and Assemblymembers Catherine Stefani and Chris Rogers.

- **CRRA:** NCRA is now designated a California Resource Recycling Association Regional Organization along with Zero Waste San Diego. We have been working cooperatively since inception, and since 1999, the beloved NCRA Players have performed to large crowds at the annual California Resource Recycling Association Conference. This year in Monterey, Finding Zero was the theme and as usual musical chaos was the scene! President Freddy Coronado delivered a well received presentation on the State of NCRA during the closing plenary, while the Zero Food Waste and Zero Waste Schools Committee led important topic lunches.
- **ZWUSA:** For the sixth year, NCRA assisted Zero Waste USA with the virtual National Zero Waste Conference by providing online conference tech support. ZWUSA also collaborates with NCRA in organizing and teaching Introduction To Recycling.
